regarding the planned merger of the companies ThermWet s.r.o. and LICON HEAT s.r.o. and the change of the business name to LICON s.r.o

Dear Madame/ Sir,

We would like to inform you about the planned merger of the company ThermWet s.r.o., ID No. 28516401, with registered seat at Vlárská 1454/1, Uhřetěves, 104 00 Praha 10, registered in the Commercial Register maintained by the Municipal Court in Prague, file No. C 147307 ("**ThermWet s.r.o.**") as the dissolving company and LICON HEAT s.r.o, ID No. 60462183, with registered seat at Svárovská 699, 463 03 Stráž nad Nisou, registered in the Commercial Register maintained by the Regional Court in Ústí nad Labem, file No. C 45470, as the successor company, and at the same time of the change in business name of the company LICON HEAT s.r.o. to LICON s.r.o. ("**LICON s.r.o.**"), on the basis of the merger project, the full wording of which is available in the collection of documents of the commercial register of both companies (the "**Merger**").

The merger's registration in the Commercial Register and the change of the corporate name to LICON s.r.o. are scheduled to take effect on the 1st of March 2024.

As a result of the Merger, ThermWet s.r.o. will be dissolved and its assets will be transferred to the successor company LICON s.r.o. LICON s.r.o. will thus enter into the legal status of ThermWet s.r.o.

The rights and obligations under any contractual relationships, any arrangements or other agreements concerning ThermWet s.r.o. will remain in force and will automatically pass to LICON s.r.o. without any changes by law. All concluded contracts are to be considered as if they had been concluded by LICON s.r.o., without the need to conclude any amendments according to the law.
